9:00 a.m.: Jared Boast made a motion to accept the Agenda for August 22, 2023, with an amendment to include propane bid openings, Rob Cummings provided a second. All in favor; motion carried.

Rob Cummings made a motion to accept the Commission Meeting Minutes from August 15, 2023; Jared Boast seconded the motion. All in favor; motion carried.

Amy England entered the meeting.

There was no mail or other correspondence presented. County officials had nothing to report. There was no citizen participation.

Tammy Zuzack introduced herself and said that she was the new Nutrition Program Associate for the Crawford County Extension.

9:06 a.m.: Cindy Redburn entered the meeting.

Bids for propane were opened; only one was received. Boland Energy's bid was \$1.49 per gallon from September 1, 2023 until August 31, 2024. Steve Black made a motion to accept the bid. Jared Boast seconded the motion. All in favor; motion carried.

Discussion was held regarding the formation of a board to manage disbursement of funds the county had received from the opioid settlement. It was agreed that it would be a five member board, with two members serving a three-year term, two members serving a two-year term, and one member serving a one-year term. Advertisement for people interested in serving on the board would be published in the newspapers for the next three weeks, with a review of the applicants being done at the Commission meeting September 19. The fund balance is around \$104,000 and the county will continue to receive deposits for several years. Those interested in receiving funds from the account would approach the board, then board would give their request for consideration to the commission for disbursement.

Discussion was held regarding FEMA's initial assessment of storm damage in the northern part of the county that had occurred on August 3, 4, and 5th.

Pat Schwent and a citizen entered the meeting. Pat Schwent asked for a tax redemption of \$634.59 to allow the release of surplus funds in order to redeem the property at 924 Old Leasburg Road. Jared Boast made the motion. Rob Cummings seconded the motion. All in favor; motion carried. Pat Schwent and the citizen exited the meeting.

Cindy Redburn was advised that any project over \$17,000 had go through the bid process.
