Jerry Beers opened the meeting with prayer and exited the meeting.

9:00 a.m.: Rob Cummings made a motion to accept the agenda for the April 30, 2024, meeting. Jared Boast provided a second. All in favor; motion carried.

Jared Boast made a motion to accept the Commission Meeting Minutes from April 23, 2024, and the closed session meeting minutes from April 16, 2024. Rob Cummings seconded the motion. All in favor; motion carried.

Rob Cummings stated that Crawford County had been awarded a \$1.5 million grant for the John Coleman and Sellers Road project, and it was the only grant awarded in Missouri. Rob Cummings wanted to recognize Danny Brown and his efforts to secure the grant. Jared Boast stated that the road districts in Crawford County have received between \$15-\$17 million over the past 10 years in grants. The Road District commissioners' participation in the meetings with TAC and being part of that committee had contributed to receiving those grants.

9:10 a.m.: Jeff Banderet introduced Bryan Boyce with Great Rivers Engineering and presented paperwork for signatures so that upcoming projects on Little Shoal, Butts and High Point Road could continue.

9:25 a.m.: Jared Boast made a motion for a property owner to receive surplus funds on three different parcels of land on Thickety Ford Road in the amounts of \$30,442.73, \$9,437.40 and \$1350.41, executing the redemption process on each parcel. Rob Cummings seconded the motion. All in favor; motion carried. Pat Schwent and the property owner exited the meeting.

9:30 a.m.: Corky Stack presented a pay request for the coroner's building in the amount of \$105,207.73. The commission signed the request. Corky Stack exited the meeting.

9:39 a.m.: Citizens' Participation: Judi Aldrich had questions regarding Riverside Road and the coroners' project.

9:48 a.m.: Judi Aldrich and Kathy Berti exited the meeting.
