

Crawford County Commission met pursuant to adjournment with these members present: Steve Black, Presiding Commissioner; Rob Cummings, Commissioner District 1; Jared Boast, Commissioner District 2; De Dee Hamilton; and the following proceedings were had to viz;

Attendees at the beginning of the meeting included Kellie Vestal, Karen Sikes, Pat Schwent, Kim Cook, Richard Jensen, Chad Barton, David Gargus, Mark Pfeiffer, Hunter Phillips, Tammy Zuzack, Cindy Redburn, Sue Greenstreet, DaShawna Pellegrino, Laura Bennett, Joseph Thomeczek II, Justin Griffith, Joyce Griffith, Richard White, Jack Harmon, Mark Wenner, Judi Seemiller, Michael Lovell, Dennis Roedemeier and Rob Viehman.

Dennis Roedemeier opened the meeting with prayer.

9:00 a.m.: Steve Black said it was necessary to amend the agenda to include Joan King as a scheduled appointment. Rob Cummings made a motion to amend the agenda for the August 13, 2024, meeting of the Crawford County Commission. Jared Boast provided a second. All in favor; motion carried.

Jared Boast made a motion to accept the minutes for the July 23, 2024, Crawford County Commission meeting. Rob Cummings seconded the motion. All in favor; motion carried.

Karen Sikes advised that the \$2 million in ARPA funds that Crawford County had received had been audited, and that the audit had gone great. The City of Cuba has requested ARPA funds in the amount of \$180,333.40, of the \$300,000 they have been allocated. The Opioid Settlement Fund received \$238,614.88, bringing the total in the fund to \$381,588.50.

Kellie Vestal presented July supplementals for signature.

9:10 a.m.: Steve Paulus and Corky Stack entered the meeting.

9:13 a.m.: Steve Black advised that Capital Quarries had informed him that there is no timeline available as to when a permit will be issued from DNR.

Steve Black addressed an issue with Facebook posts and thought that county employees should be spoken to, regarding what they post on Facebook.

Rob Cummings made a motion to allow surplus funds to be received in the amount of \$4174.58 for property at 106 Biddle Street in Steelville, Missouri. Jared Boast seconded the motion. All in favor; motion carried. Mark Wenner exited the meeting.

9:22 a.m.: Tammy Zuzack, with the Extension Council gave an update to the commission.

It was agreed to have the Tax Levy hearing on Tuesday, August 27<sup>th</sup>, 2024, at 10:00 a.m.

Joan King was not present for the scheduled appointment.

9:35 a.m.: Steve Paulus explained what needed to happen to correct the boundary issue that was discovered at the August 6, 2024 Primary Election. The issue affected 139 voters; 36 of whom voted in the election, resulting in the error not having any bearing on the election results. Steve Paulus will draft a new ordinance to clarify and correct the boundary line.

Jared Boast made a motion to allow surplus funds to be received in the amount of \$59.57 for property at 617 Forest Street in Cuba, Missouri. Rob Cummings seconded the motion. All in favor; motion carried.

10:22 a.m.: Steve Black advised that the garage located at 409 S. Franklin in Cuba, Missouri, had been sold as a lease/purchase agreement for \$129,000.

10:25 a.m.: Citizens participation: Corky Stack had a pay request for the coroner's building, to Alexander Construction, in the amount of \$55,939.87. The motion was made and seconded, to approve the pay request to Alexander Construction. All were in favor; motion carried. Jared Boast made a motion to pay AE Design \$7146.83. Rob Cummings seconded the motion. All in favor; motion carried. Corky Stack exited the meeting.

There was an inquiry regarding the County Clerk's absence. The Clerk's office is open and will continue to conduct county business.

Jared Boast made a motion to enter into the TEEP Program. Rob Cummings seconded the motion. All in favor; motion carried. This program is provided by the state for funding in consultation or engineering costs for state highway studies. There has been \$18,000 allocated for a study at the Lindberg Road and Hwy 19 intersection. This is a shared cost with the state and the county. Each road district will pay \$1500, which is the county's portion, of \$3000.

It was noted that the Opioid Fund Disbursement Board is meeting in early September.

The motion was made to adjourn the August 13, 2024, meeting of the Crawford County Commission. The motion was seconded. All in favor; motion carried.
