Crawford County Commission met pursuant to adjournment with these members present: Steve Black, Presiding Commissioner; Mark Pfeiffer, Commissioner District 1; Jared Boast, Commissioner District 2; County Clerk, Kim Gibbs and De Dee Hamilton; and the following proceedings were had to viz;

Attendees at the beginning of the meeting included Darin Layman, Rob Viehman, Tamara Snodgrass, Robert Bass, Cindy Redburn, Bob Bowen, Tonya Bowen, Kellie Vestal, Richard Jensen, Paul Wilkerson, Tina Mason, Colin Cottrell, Larry Abdo, Bill Lunsford, Greg Doss, Keenan Hofstetter, Holly Ward, and Julie Bass.

Andy Keymann opened the meeting with prayer and exited the meeting.

9:02 a.m.: Jared Boast made a motion to accept the agenda for the April 29, 2025, meeting of the Crawford County Commission, with an amendment to include discussion regarding county employee health insurance. Mark Pfeiffer seconded the motion. All in favor; motion carried.

Mark Pfeiffer made a motion to accept the Crawford County Commission meeting minutes of April 15, 2025. Jared Boast seconded the motion. All in favor; motion carried.

9:07 a.m.: Mark Pfeiffer made a motion to accept the letter of resignation from Rodger Windle from the SB40 Board, effective May of 2025. Jared Boast seconded the motion. All in favor; motion carried.

Steve Black made a motion for Jodi Layman to stay on the SB40 Board for another term. Jared Boast seconded the motion. All in favor; motion carried.

County Officials: Darin Layman advised that the drone program is up and running, and the K-9 program is close.

Kim Gibbs stated that because of a four-way tie for Trustee in the April 8, 2025 election, the Village of St Cloud will be having a Special Election on June 10, 2025. The clerk's office will be the polling place for this election only and the office will be open from 6 a.m. until 7 p.m. on that day. The clerk's office will issue paper ballots and hand count the ballots as there are only 41 voters in the Village. The hand count and results will be complete that evening.

9:11 a.m.: Tamara Snodgrass from MRPC addressed the crowd regarding floodplain insurance and floodplain permits. Much discussion was held with the final determination being that some of those in attendance would provide a letter for the commission to review requesting that Congress change legislation concerning floodplain insurance and permitting requirements. None of the commissioners were in favor of telling those in attendance they needed a permit before they were allowed to start recovery work on their property after a flood.

10:30 a.m.: The meeting continued with the commission, Kim Gibbs, De Dee Hamilton, Bob and Tonya Bowen, Richard Jensen, and Darin Layman in attendance.

Under Old Business: Steve Black made a motion to accept Missouri Blue Shield Resolution #42925. Mark Pfeiffer seconded the motion. All in favor; motion carried. The commission signed the resolution. See attached. The resolution is a commitment to Public Safety and

Crime Reduction between Crawford County and Law Enforcement. This will help Crawford County be eligible for \$10 million in grant accessibility.

Mark Pfeiffer made a motion to remove \$50,000 from the landfill account and place it in the General Revenue account. Jared Boast seconded the motion. All in favor; motion carried. The landfill account is only required to have \$19,000 in the account and the balance was over \$77,000.

10:35 a.m.: Kellie Vestal and Cindy Redburn entered the meeting.

10:36 a.m.: Steve Black made a motion to accept the bid of \$27,581.77 from SE Services for a 40 KW Generac generator for the health department. Jared Boast seconded the motion. All in favor; motion carried. Jared Boast noted that the transfer from the landfill account would cover the cost of the generator and FEMA would be reimbursing the county for the generator.

Steve Black stated that the health department lost two vehicles in the November 2024 flood and only one vehicle needed to be replaced. A bid was placed and won with MRPC for a 2016 Chevy Malibu.

10:41 a.m.: Kim Gibbs gave a breakdown of the county employee health insurance renewal.

10:52 a.m.: Jared Boast made a motion to enter into an agreement with United Heathcare to pay 100% of the county employee health insurance if on the base plan and 90% if on the buy-up plan; with the option to allow spouses to be on the county health insurance plan, at their expense. Employees will gain \$77 per month since the county is now paying 100% of their health insurance.

10:55 a.m.: Van Kitchens entered the meeting.

10:55 a.m.: Under citizens' participation: Bobby and Tonya Bowen appreciated the work that had been done on McPherson Road and wondered about the plan for the road in the future.

11:08 a.m.: Bobby and Tonya Bowen exited the meeting.

11:08 a.m.: Van Kitchens presented an ancillary benefit insurance proposal, Attentive Preventative Care Management. Kim Gibbs and the commission asked for references from other counties that were using the benefits for the proposed tax savings. Van Kitchens was to provide the references and the commission agreed to review the proposal. Jared Boast wanted to compare with other municipalities and government entities that have had the policy for two years.

12:13 p.m.: Mark Pfeiffer made a motion to adjourn the April 29th, 2025, meeting of the Crawford County Commission. Jared Boast seconded the motion. All in favor; motion carried.
