

Crawford County Commission met pursuant to adjournment with these members present: Steve Black, Presiding Commissioner; Mark Pfeiffer, Commissioner District 1; Jared Boast, Commissioner District 2; County Clerk Kim Gibbs and De Dee Hamilton; and the following proceedings were had to viz;

Attendees at the beginning of the meeting included Darin Layman, Rob Viehman, Kellie Vestal, Karen Sikes, Richard Jensen and Gary Mace.

Gary Mace opened the meeting with prayer.

9:03 a.m.: Mark Pfeiffer made a motion to accept the agenda for the July 21, 2025, meeting of the Crawford County Commission. Jared Boast seconded the motion. All in favor; motion carried.

9:04 a.m.: Mark Pfeiffer made a motion to accept the Crawford County Commission meeting minutes for the July 8, 2025, meeting of the Crawford County Commission. Jared Boast seconded the motion. All in favor; motion carried.

A draft of the commission meeting minutes for July 15, 2025, was presented.

County officials report: Karen Sikes needed signatures from the commission for the disbursement of the fund requests from the OFDB last week.

Jared Boast advised that Road District 2 was selling some of their equipment through Purple Wave.

Steve Black stated that he did not receive a call from FEMA last week. He called SEMA and they advised to wait about a month and consider filing a complaint with the EPA, as Dent County had done.

Steve Black made a motion to hire the boring company to create and run propane lines that will hook to the existing tank behind the Assessor and Collector's buildings. Mark Pfeiffer seconded the motion. All in favor; motion carried. The cost of the project is around \$7000 and considering that this is a safety issue, the commission agreed it should be done as soon as possible.

9:12 a.m.: Jared Boast made a motion for the release of surplus funds in the amount of \$20,220.64 for property at 164 Edwin Lane in Cuba, executing the redemption process. Mark Pfeiffer seconded the motion. All in favor; motion carried.

Mark Pfeiffer made a motion for the release of surplus funds in the amount of \$451.92 for property at Hwy 8 East in Steelville, executing the redemption process. Jared Boast seconded the motion. All in favor; motion carried.

Mark Pfeiffer made a motion for the release of surplus funds in the amount of \$1956.87 for property at Hwy 8 East in Steelville, executing the redemption process. Jared Boast seconded the motion. All in favor; motion carried.

Pat Schwent exited the meeting.

9:17 a.m.: Under old business: Mark Pfeiffer declined all bids for the removal and replacement of the bridge on Crabtree Road. The Nature Conservatory thought they could allocate funds benefitting the county more at a different low-water location. GPS coordinates will be sent to the NC.

Jared Boast advised that the removal and replacement of the bridge on McWilliams Road will be tabled until the next commission meeting on August 5, 2025 meeting.

9:20 a.m.: Citizen participation: Confirmed that there will be no commission meeting next Tuesday, July 29, 2025.

9:21 a.m.: Discussion was held regarding the success of the Crawford County Fair last week. The livestock auction brought in \$489,631.29 for the 4H kids in the county.
