Attendees at the beginning of the meeting included Darin Layman, Rob Viehman, Kellie Vestal and Richard Jensen. Troy Royer, Ashley Miller, and Brenna Young, from the State Auditor's office, Cindy Redburn, Judi Aldrich, James and Margaret Harmon, Jenni Pilkenton, PJ Myers, Tammy Zuzack, Jackie Hunt and Andy Keymann.

Andy Keymann opened the meeting with prayer.

9:03 a.m.: Mark Pfeiffer made a motion to accept the agenda for the August 5, 2025, meeting of the Crawford County Commission, with an amendment to include a tax redemption. Jared Boast seconded the motion. All in favor; motion carried.

9:04 a.m.: Mark Pfeiffer made a motion to accept the Crawford County Commission meeting minutes for the July 15, 2025, meeting of the Crawford County Commission. Jared Boast seconded the motion. All in favor; motion carried.

A draft of the commission meeting minutes for July 21, 2025, was presented. No draft of the commission meeting minutes for July 29, 2025 was presented, as there was no meeting on that day.

9:05 a.m.: Kellie Vestal presented supplementals for the month of July for signature.

9:08 a.m.: Darin Layman advised that there were people living behind the assessor and collector's building. The county needed to put up no trespassing signs and maybe a gate behind the building.

9:10 a.m.: Steve Black stated that he had still not received a call from FEMA so he was going to reach out to the former rep he had been working with.

9:12 a.m.: Under Old Business: Demolition bids of the former extension building were opened: one bid was received. Steve Black made a motion to accept the bid to tear down and haul off the scrap from the old extension building in the amount of \$8750.00 from PJ Myers Hauling and Excavating. Mark Pfeiffer seconded the motion. All in favor; motion carried.

9:18 a.m.: Jared Boast advised that the bid for the bridge replacement on McWilliams Road should be tabled until next week, August 12, 2025. This will be an in-house replacement of the creek crossing; he added that the 400 block of Baldwin Road would be closed from August 14th-October 1st, 2025.

9:19 a.m.: Pat Schwent entered the meeting. Mark Pfeiffer made a motion to receive surplus funds in the amount of \$108.25 for property located at 330 Hwy E in Steelville, executing the redemption process. Jared Boast seconded the motion. All in favor; motion carried.

Sandra Orr entered the meeting.

9:22 a.m.: Citizen Participation: Judi Aldrich handed out incident reports regarding a situation on Valleyside and Eaton Cemetery Road. Judy Aldrich and Sandra Orr exited the meeting.

9:29 a.m.: James Harmon had concerns about the boat ramps at Birds Nest and Fisherman Springs, and county roads.

Tammy Zuzack advised that the SNAP Program in Crawford County was ending due to the elimination of federal funding. See attached.

9:40 a.m.: Jared Boast made a motion to enter into closed session pursuant to 610.022.18 for discussion with the State Auditors office. This was later corrected to pursuant to 610.021.18. Mark Pfeiffer seconded the motion. All in favor; motion carried.

11:47 a.m.: The commission was back in open session with Kim Gibbs, De Dee Hamilton and Darin Layman.

12:15 p.m.: Mark Pfeiffer made a motion to adjourn the August 5, 2025, meeting of the Crawford County Commission. Jared Boast seconded the motion. All in favor; motion carried.
