9:00 a.m.: Tommy Miller opened the meeting with prayer.

9:02 a.m.: Mark Pfeiffer made a motion to accept the agenda for the November 18, 2025, meeting of the Crawford County Commission. Jared Boast seconded the motion. All in favor; motion carried.

9:03 a.m.: Mark Pfeiffer made a motion to accept the Crawford County Commission meeting minutes for the October 28, 2025 and November 4, 2025 meetings of the Crawford County Commission.

9:04 a.m.: County Officials: Mark Pfeiffer said that Woolsey Road box culvert repair had begun that morning. He mentioned that the project may be delayed due to rain we are expecting but should be finished within 2 weeks. He also mentioned that they had a preconstruction meeting the previous week for Sellers Bridge. Great Rivers had several papers for the Commission to sign for that project. The start date for the Sellers Road project is scheduled for December 8, 2025 and should be completed by the end of February 2026. They are waiting on logs to be supplied from the Forestry Department to be used to rebuild a wall damn to provide bank stabilization.

9:08 a.m.: Jared Boast said the Nature Conservancy was wanting a list of locations of annual flowing streams to make improvements to wash out areas. The Little Bourbeuse Bridge crossing was the most eligible one mentioned for the repairs to be done.

9:13 a.m.: Kim Gibbs mentioned about the food drive the county is hosting and, also the new updated website with the Crawford County news link.

9:15 a.m.: Karen Sikes mentioned she and Kim Gibbs would not be at the Commission meeting on Tuesday, November 25<sup>th</sup>. They will be at the annual MAC conference.

9:16 a.m.: Kellie Vestal brought up discussion regarding an update on cyber security.

9:18 a.m.: Darin Layman said that in his correspondence with the new FEMA rep, it was mentioned that we are in the cue for the Counties reimbursement. It may end up being less than what we were initially expecting. We had originally expected to have the funds by this past June, but with all the turnover with FEMA representatives, it has been further delayed. He also

Jackie Hunt inquired about the total time limit per meeting set aside for citizen participation. Steve Black mentioned that there is currently no time limit set for the entire citizen participation portion of the meeting, however, the 5 minute time limit per individual is still in place.

10:15 a.m.: Bradley Clark, A representative from Senator Josh Hawley's office stopped in to introduce himself and see if the County has any issues or concerns that he may be able to help with. He mentioned that he would be happy to reach out to our FEMA representative to see about getting the reimbursement funds any faster. Richard Jensen also mentioned about possibly getting easier access for creek rock to be purchased for road maintenance. All issues he is more than happy to try to help the County with.
